

ATCP 160.53 – SWINE – DEPARTMENT 3
Judging: Wednesday, 8:00 a.m. – Stock Pavilion

1. All junior swine exhibitors must be certified in the (MAQA) Meat Animal Quality Assurance program by June 1st to exhibit swine at the Green County Fair.
2. All barrows and gilts exhibited at the Green County Fair must be accompanied by a Certificate of Veterinary Inspection or an Intrastate Health Certificate signed by an accredited veterinarian within a 30 day period prior to the fair. Papers will be checked prior to unloading swine at the fair. Refer to complete health regulations in front of book.
3. Barrows will be accepted on the fairgrounds between noon and 9:00 p.m. on Monday. All swine must be in place by 9:00 p.m. on Monday evening.
4. Exhibitors will not be allowed to wash their pigs between 8:00 a.m. and the end of the weigh-in on Tuesday morning. No power washers will be allowed.
5. Green County Junior Fair livestock exhibitors are **required** to fit their own animals for the Junior Show once they are on the fairgrounds. They may be **assisted** by immediate family members, (parents, step-parent, legal guardians, brothers and sisters, or by another Green County Junior Fair exhibitor). Failure to abide by this rule will make the animal ineligible for the Junior Show.
6. Adults are **not** allowed inside the holding pen during the swine show.
7. All swine exhibitors are responsible for providing their own wood shavings for their pens.
8. **Only one pen will be allotted for each swine exhibitor. Please pen you fair pigs together prior to fair to eliminate fighting.**
9. Hogs with excessively short hair may be docked by the packer.
10. The Green County Swine Show is a Terminal Show. Swine cannot be removed from the fairgrounds once they are unloaded from the trailer. **All non-auction hogs will be shipped to a terminal market.**
11. Swine exhibitors are responsible for cleaning their own pens after the auction pigs are loaded out on Sunday. If pen gates are removed for cleaning they must be put back in place.
12. All swine exhibitors must complete and sign a Green County Fair Swine Affidavit form that lists all medical treatments given to swine prior to the fair. One form is required per family and must be turned into the UW-Extension Office on the date specified on the form. This form is required by Tyson Fresh Meats Inc.
13. All pigs are subject to testing for drug residues by Tyson Foods. If any pig tests positive for drug residues the entire immediate family will no longer be allowed to exhibit swine at the Green County Fair.

Market Lots – Rules and Instructions

1. Market barrows may be purebred or crossbred pigs.

2. Only exhibitors who are members of a Green County 4-H club or FFA chapter are eligible to weigh swine at the Green County Swine Weigh-In and exhibit at the Green County Fair Junior Swine Show. All Market and Performance barrows must have been weighed and identified at the spring weigh-in.
3. All swine will be weighed on Tuesday starting at 8:00 a.m. All pigs must be weighed in order by 4-H club or FFA chapter. Repeat weighing or holding animals until the end of weigh-in is not allowed.
4. Market barrows must weigh a minimum of 225 lbs. at fair to be eligible for the show. Swine not making this weight will be transported to slaughter on Thursday morning. All handling and hauling costs will be paid by the exhibitor. (If an exhibitor does not have any barrows that make the minimum weight they will be allowed to exhibit one barrow – the heaviest – in the Junior Show.)
5. Market lot, auction and performance barrows must be designated at the scales immediately following the weighing of the pigs.
6. Each exhibitor may bring a maximum of 4 total pigs, including both barrows and gilts. No more than 2 of which can be gilts. Exhibitors may bring a maximum of 4 barrows with a maximum of 3 in the live show and one in the performance lot.
7. Market barrows should be entered in Lot 100. Please indicate on your entry blank the number of animals being entered.
8. Barrows will be grouped into lots according to their fair weights. Lot divisions will be posted prior to 8:00 a.m. on Wednesday.
9. No more than one premium will be awarded an exhibitor under one weight lot, except for the heaviest class.
10. Swine Auction – see Livestock Auction rules.
11. Breeding stock will not be allowed on the grounds.
12. All swine must go directly to slaughter after the fair.
13. ALL pigs that will NOT be sold in the livestock Auction will be loaded out Thursday morning. Payment will be based on live fair weight minus shrink at final market destination. Death losses incurred during transport to slaughter and carcass quality deductions will be distributed over all the exhibitors' final payments.

PERFORMANCE LOT

Performance Show Rules and Instructions

1. Performance animals must be barrows and must have been weighed at spring weigh-in.
2. Performance barrows will be weighed on Tuesday starting at 8:00 a.m. All barrows will be weighed by club groups.
3. All performance barrows will be scanned for backfat and loin eye while on the scale. Barrows must have a minimum backfat thickness of .5" to be eligible for the performance class.
4. Only exhibitors who are members of a Green County 4-H club or FFA Chapter and/or reside in Green County are eligible to weigh barrows at the weigh-in and exhibit at the Green County Junior Fair.
5. Only one animal per exhibitor may be entered in the Junior Show Swine Performance Contest.
6. Performance animals will be entered in Lot 150. The performance animal may not be entered in the individual market barrow Lot 100.
7. The Performance Contest animals will be judged live at the fair. Performance animals that are not sold in the auction will be transported to slaughter by the Green County Pork Producers. Fair ribbons and fair premiums will be awarded on live placing.
8. Exhibitors will be paid the current market price for their barrow.
9. Barrows entered in the Performance Lot can be sold in the auction.
10. The management reserves the right to interpret and enforce all rules and regulations.
11. Overall Grand and Reserve Champion Performance animals will be evaluated on a basis of 20% live placing and 80% carcass ranking.
12. The Green County Pork Producers will cover the cost of scanning one performance pig per exhibitor. Exhibitors can have additional pigs scanned at a cost of \$6.00/pig.
13. All performance animals must weigh a minimum of 235 pounds.

Market Gilt – Rules and Instructions

1. All gilts will go directly to slaughter after the show. All gilts will be loaded out Thursday morning

2. Each exhibitor can show a maximum of two gilts. The gilts will count towards the maximum total of 4 pigs per exhibitor. If an exhibitor shows two gilts he is limited to only 2 barrows in the Junior Show.
3. Market Gilt Lots will be divided by final fair weight. Market gilts will be weighed by club group with other pigs at 8:00 a.m. on Tuesday.
4. Market gilts can not be sold in the Livestock Auction.
5. Market gilts must weigh a minimum of 225 pounds to show. Gilts not making weight will be transported to market on Thursday morning.
6. Green County Pork producers will pay premiums of \$6 - \$5 - \$4 - \$3, based on the Danish system.

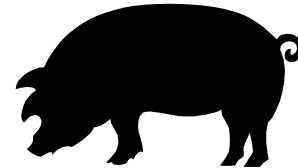
